When Hamied went to Brussels in 2000, a year's treatment with AIDS cocktail cost a patient \$10,000 to \$12,000. Western countries holding the patents insisted they had to earn back their original research and development expenses. Hamied said it was time the victims got treatment regardless of the patent issues and offered to sell his cocktail for \$800 to \$1,000 per year. A few weeks later, he lowered the price to \$600 for government purchases. Today, Thailand and Brazil have been manufacturing and selling the AIDS cocktail. Last month, Cipla won the World Health Organization approval to market the AIDS drug wherever local governments agree to allow its sale.

Hamied is proof that you can do well by doing good: the anti-AIDS cocktail he sells sustains lives while helping maintain his own high standard of living. Hamied, who earned his doctorate in chemistry from the University of Cambridge, considers the AIDS battle part of a broader campaign to maintain India's loose patent regime. India's patent laws are supposed to meet the World Trade Organization standards if the country ratifies the WTO's intellectual property treaty. Hamied says that could make his people very helpless against profiteering drug companies and India has an estimated 4 million HIV-positive cases.
